### Objectives and investment policy

#### Objective

- Seek positive return regardless of market conditions (absolute return) while placing emphasis on the preservation of investor's capital in the medium term.

#### Portfolio securities

- The Investment Manager anticipates that under normal market conditions the Sub-Fund will mainly invest in equities from anywhere in the world, including emerging and frontier markets. The Sub-Fund may invest in these securities directly or may invest indirectly by investing in exchange-traded funds (ETFs), including short ETFs. Investments in other funds may incur a duplication of certain fees. The Sub-Fund may also invest in bonds. The Sub-Fund may use derivatives to reduce or cancel out its exposure to various investment risks (hedging).

#### Investment process

- The Investment Manager chooses portfolio securities by looking at global economic factors and trends. From analysis of these factors, the Investment Manager determines the desired mix of countries, industries and companies.

#### Designed For

- Investors who want to invest in equity markets through an active management strategy and who have an investment horizon of at least 3 years.

#### Sub-Fund's Reference currency EUR

You can place orders to buy or sell Sub-Fund shares on any given Luxembourg business day.

The Sub-Fund issues only accumulation shares (shares in which any income earned is added to the share price).

#### Terms to Understand

- **Equities** Securities that represent a share in the business results of a company.
- **Exchange-traded funds (ETFs)** A type of mutual funds that track a basket of securities (usually an index) and are traded on stock exchanges. A short ETF is a fund whose value moves in the opposite direction of its underlying securities
- **Shares** Securities that represent a share in the business results of a company.
- **Frontier markets** Within emerging markets, those that are particularly small, new or under-developed.
- **Bonds** Securities that represent an obligation to repay a debt, with interest. Below investment-grade bonds generally pay higher interest rates but are considered less likely to make all scheduled payments.
- **Derivatives** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

- The value of an investment in the Sub-Fund can go up and down. When you sell your shares, they may be worth less than what you paid for them. If your currency as an investor is different from the subscription currency of the Sub-Fund, changes in currency exchange rates could reduce any investment gains or increase any investment losses.
- The risk/reward rating above is based on medium-term volatility (actual or estimated variations in the Sub-Fund's share price over five years). Going forward, the Sub-Fund's actual volatility could be lower or higher, and its rated risk/reward level may be changed.
- The Sub-Fund's risk level reflects the following factors:
  - Equities generally have higher risks than bonds or money market instruments.
  - Investments are made to reduce the Sub-Fund's share price volatility.

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

- **Default risk** A bond may lose part or its entire value if the issuer is unable to pay interest or repay principal on schedule.
- **Derivatives risk** Certain derivatives could increase Sub-Fund volatility or expose the Sub-Fund to losses greater than the cost of the derivative.
- **Counterparty risk** The Sub-Fund could lose money if an entity with which it does business becomes unwilling or unable to honor its commitments to the Sub-Fund.
- **Management risk** Portfolio management techniques that have worked well in normal market conditions could prove ineffective or detrimental during unusual conditions.
- **Operational risk** In any market, but especially in emerging markets, the fund could lose some or all of its money through a failure in asset safekeeping or through fraud, corruption, political actions or any other unexpected events.
- **Liquidity risk** Certain securities could become hard to value, or to sell at a desired time and price.

## Charges

The charges you pay as an investor in the sub-fund go to cover sub-fund operating costs, including marketing and distribution costs. These charges reduce the performance of your investment.
